The following important activities were undertaken by the Ministry during May, 2024

1. PM-JANMAN:

Out of the newly sanctioned 916 Anganwadi Centres (AWCs) under PM-JANMAN, 520 AWCs have been operationalized as on 31.05.2024.

2. G20 Women Empowerment Working Group meeting held in Brazil on 13-14th May, 2024:

The second meeting of G20 Women Empowerment Working Group (WEWG) was held in Brazil on 13-14th May, 2024 for which Ministry of Women & Child Development is the nodal Ministry. Discussion on all 3 priority areas of WEWG viz. (i) Equality (ii) Confronting Misogyny and Violence (iii) Climate Justice were held during the meeting. The country statement for each of the priority areas was presented by the Indian delegation led by the Joint Secretary-International Co-operation (Dr. Preetam B. Yashvant).

1. पीएम-जनमन:

पीएम-जनमन के तहत स्वीकृत किए गए 916 नए आंगनवाड़ी केंद्रों (एडब्ल्यूसीसी) में से दिनांक 31.05.2024 तक 520 नए आंगनवाड़ी केंद्रों ने कार्य करना शुरू कर दिया।

2. ब्राज़ील में दिनांक 13-14 मई, 2024 को आयोजित जी20 महिला सशक्तिकरण कार्य समूह की बैठक:

जी20 महिला सशक्तिकरण कार्य समूह (डब्ल्यूईडब्ल्यूजी) की दूसरी बैठक दिनांक 13-14 मई, 2024 को ब्राज़ील में आयोजित की गई जिसके लिए महिला एवं बाल विकास मंत्रालय नोडल मंत्रालय है। इस बैठक के दौरान डब्ल्यूईडब्ल्यूजी के सभी 3 प्राथमिकता वाले क्षेत्रों अर्थात् (i) समानता (ii) स्त्री-द्वेष और हिंसा का सामना करना (iii) जलवायु न्याय पर चर्चा की गई। संयुक्त सचिव-अंतर्राष्ट्रीय सहयोग (डॉ. प्रीतम बी. यशवंत) के नेतृत्व में भारतीय प्रतिनिधिमंडल द्वारा प्रत्येक प्राथमिकता वाले क्षेत्र के लिए देश का वक्तव्य प्रस्तुत किया गया।
