Recent updates/enhancements in Poshan Tracker Application

1.	Stock Register Module Poshan Tracker App / Action Centre / Stock Register	The Poshan Tracker App now has a Stock Register module for Anganwadi workers, allowing monthly tracking of SNP stock with detailed records, date-wise entry for received stock, and updated distribution based on daily THR/CM, enhancing efficiency in stock management and beneficiary tracking at AWCs.
2.	Supplementary Nutrition Report Poshan Tracker / Department User Login / Monthly Reports / Supplementary Nutrition	 The Poshan Tracker Dashboard has introduced a new report on Supplementary Nutrition that represents. 5.	/ AWC Migration	The AWC Migration module now features a powerful search function enabling Anganwadi Workers to locate beneficiary details by their registered mobile number before migration, while also requiring beneficiaries to verify their mobile number prior to initiating the migration process, enhancing data accuracy and workflow efficiency
6.	Migrate Pregnant Women to Lactating Mother Poshan Tracker App / Beneficiaries / Pregnant Women / Migrate to Lactating Mother	The updated module for transitioning from pregnant women to lactating mothers now mandates Anganwadi Workers to record details of the newborn, a significant improvement from the prior version, allowing simultaneous monitoring of both mother and child as beneficiaries in the Poshan Tracker Application.
7.	Miscarriage/Abortion/Still Birth Poshan Tracker App / Beneficiaries / Pregnant Women / Miscarriage, Abortion, Still Birth	The Miscarriage/Abortion/Still birth feature has now been made part of the pregnant women beneficiary profile to assist the Anganwadi Worker to capture the requisite details in the pregnant women profile.

New Supportive supervision section in PT Admin Dashboard admin.poshantracker.in / Admin / Supportive Supervision	The Poshan Tracker Admin Dashboard has now been updated with an additional feature to view the status of monthly on-boarding of the officials. DPO/CDPO/MS on-boarded count will appear based on State, District, Project selection criteria.
9.	New Beneficiary redressal section in PT Admin Dashboard admin.poshantracker.in / Admin / Dashboard	The Poshan Tracker dashboard has now been updated with an addition feature to view the status of Beneficiary redressal. The officials can now monitor the status of the all the Tickets that has been raised, resolved and are pending at National, State, District and Project Level. The Beneficiary redressal dashboard further indicates the Help Topic wise Ticket Status (Resolved, Pending) at AWW and Supervisor level.
10.	Add/Edit feature disabled for the National Users in PT Admin Dashboard	The Add/Edit rights that was previously being provided to National Level officials has now been disabled for Project, Sector, AWC User, AWC master list menu items in the PT Dashboard.
11.	Village Health Sanitization and Nutrition Day and Community based Events Poshan Tracker App / More / Events	VHSND and CBE interfaces has been revamped enabling the Anganwadi Worker to manage and track vital information. The data entry process has been simplified wherein the case of VHSND, the Anganwadi Worker is required to enter the event date and number of participants, while in the case of CBE, the Anganwadi Worker is required to enter event dates and themes (Inviting women during 1st/2nd Trimester of pregnancy; Annaprasan

		Diwas; Suposhan Diwas; Getting ready for pre-school at AWC; public health messaging)
12.	Beneficiary Vaccination Poshan Tracker App / Action Centre/Beneficiary Vaccination	A new Beneficiary Vaccination module has been added to the application, enabling Anganwadi workers to track beneficiaries' vaccination status. The module monitors upcoming, completed, and overdue vaccinations, and provides a date-wise vaccination profile detailing due and given vaccinations.
13.	Gestational Weight Gain /ANC Details Poshan Tracker App / Beneficiaries / PW / GWG, ANC	The beneficiary profile has been enhanced to include an option to track ANC (Antenatal Care) details. The Anganwadi Worker has to mandatorily fill the Height, Weight, Haemoglobin and ANC date of the beneficiary.
14.	Growth Monitoring Confirmation Message	A new confirmation step in the growth monitoring process requires Anganwadi Workers to verify the accuracy of height and weight data entered into the application, aiming to minimize data entry errors and ensure reliable growth tracking for beneficiaries.
15.	Bank details removed from AWW/AWH	Fields related to bank details have been removed from AWW/AWH profile in Poshan Tracker
16.	Integration with UWIN	children vaccination records can be viewed from U-WIN, in Poshan Tracker
