Subject: Revision in Mission Saksham Anganwadi and Poshan 2.0 Guidelines Sir/Madam.

Please refer to Operational guidelines regarding implementation of "Saksham Anganwadi and Poshan 2.0" circulated vide letter No. 11/4/2021-CD-I (e-95706) dated 1st August 2022. I am directed to convey that for strengthening ICT component and better implementation and monitoring of Mission Poshan 2.0, following provisions are incorporated in the Mission Poshan 2.0 operational guidelines with immediate effect:

- a) Provision of Smart phones and data recharge support to Lady Supervisors and Block Coordinators
- b) 2% buffer for Smart phones
- c) 5% buffer for GMDs
- d) SPMU team members may travel through road/rail (2nd AC) with in State and by air (economy class) outside State, if approved by State Department. Expenditure for this will be met from Rs 1 Lakh per month already given to each State/UT for the purpose.
- 2. In this regard, States/UTs are requested to provide the details of Supervisors in enclosed performa at Annexure-I to the ministry on following email Ids (Jamal Ahmed, jamal.ahmed@nic.in and Bhavi, bhavi.dcpcr@delhi.gov.in) latest by 26 June 2024.
- 3. Buffer for smart phones (2%) and GMDs (5%) have been provisioned so that data input is not adversely affected because of mal-functioning/non-availability of these items. These buffer stocks are required to be kept and maintained at DPO level. The buffer stock is to be used in case any smart phone or GMD at any AWC is not working. Once the defective Smart phone/GMDs is/are repaired, the buffer item is required to be returned to DPO. States are required to refer letter F. No. PA/293/2022-CPMU (e-102529) dated 18th October 2023 for revised cost of Smartphone.

- No new travel budget is proposed for SPMU team members. The States/UTs are required to refer existing travel budget of Rs 1 lakh per month per State/UT as per existing Mission Poshan 2.0 guideline.
- This issues with the approval of the Competent Authority. 5.
