Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to Director, Women & Child Development, Department of Social Justice & Empowerment, Govt. of Himachal Pradesh at Ponta Sahib, Distt. Sirmur, Himachal Pradesh - Release of first installment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 2,79,66,750/- (Rupees Two Crore Seventy Nine Lakh Sixty Six Thousand Seven Hundred Fifty only) as Central Government's share for construction of a **Working Women's Hostel for 20 working women** and Day Care Centre for **30 children** at **Ponta Sahib, Distt. Sirmur, Himachal Pradesh**. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 3,72,89,000/- (Rupees Three Crore Seventy Two Lakh Eighty Nine Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

- 2. I am, accordingly, to convey the sanction of the President to the payment to the Director, Women & Child Development, Department of Social Justice & Empowerment, Govt. of Himachal Pradesh of a sum of Rs. 1,39,83,375/- (Rs. One Crore Thirty Nine Lacs Eighty Three Thousand Three Hundred Seventy Five only) being the first installment of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.
- 3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
- 5. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount for disbursement to the grantee through electronic transfer.

The expenditure involved is debitable to Major Head "2235" –Social Security and Welfare, 02-Social Welfare, 103-Women's Welfare, 70-Assistance to Voluntary Organisations for Construction of Hostels for Working Women, 70.05.35-Grant-in-aid (Plan) under Demand No. 99, Ministry of Women and Child Development during 2017-2018.
- 7. This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 8469/ JS&FA/ 2017 dated 26.07.2017. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.
- 8. Entry has been made in the GIA Register at SI. No. 3.
- 9. The organization will submit Utilization Certificate of the Grant-in-aid by 26-03-2018.
- 10. It is requested that efforts may be made for awareness generation with regard to prevention and controlling HIV/AIDS amongst the beneficiaries.
