Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in- to Niaga Welfare Society, Arunachal Pradesh - Release of first installment.

Sir,

I am directed to say that the Government of India has sanctioned a nonrecurring grant of Rs. 3,86,93,550/- (Rupees Three Crore Eighty Six Lacs Ninety Three Thousand Five Hundred Fifty only) as Central Government's share for construction of a Working Women's Hostel for 100 working women and Day Care Centre for 25 children at Survey No. 16, Nacho, Upper Arunachal Pradesh. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 5,15,91,400/- (Rupees Five Crore Fifteen Lakh Ninety One Thousand Four Hundred only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

- I am, accordingly, to convey the sanction of the President to the payment to the Niaga Welfare Society, Arunachal Pradesh of a sum of Rs. 1,93,46,775/- (Rs. One Crore Ninety Three Lacs Forty Six Thousand Seven Hundred Seventy Five only) being the first installment of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.
- The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
- The Drawing & Disbursing Officer of the Ministry of Women & Child 5. Development is authorized to draw the amount for disbursement to the grantee through electronic transfer.
