Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Secunderabad Cantonment Board, Secunderabad** at Mudfort, Secunderabad Cantonment Ward III, Hyderabad, Telangana- Release of **First** instalment.


Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 2,30,02,500/- (Rupees Two Crore Thirty Lakh Two Thousand Five Hundred only) as Central Government's share for construction of working women hostel for **50 Working Women** and Day Care Centre for 15 children at Secunderabad Cantonment Board, Secunderabad. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 3,06,70,000/- (Rupees Three Crore Six Lakh Seventy Thousand only) as admitted for construction of working women hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry. This proposal has been approved subject to the following conditions:

- (i) Ministry of Defence will give the assurance in writing that **the proposed hostel shall be available for all working women as per the scheme guidelines and not just the defence personnel (women);**
- (ii) Ministry of Defence will furnish the undertaking regarding furnishing of **Half Yearly report on monitoring of the construction and functioning of the Working Women Hostel** as per the scheme guidelines. **They will intimate the name and contact details of the nodal officer who will be responsible for sending the half-yearly report.**

2. I am, accordingly, to convey the sanction of the President to the payment to the **Secunderabad Cantonment Board, Secunderabad** of a sum of **Rs. 1,15,01,250/- (Rs. One Crore Fifteen Lacs One Thousand Two Hundred Fifty only)** being the **first instalment** of the grant for construction of working women hostel. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

4. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts and utilization certificate of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

5. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount **Rs. 1,15,01,250/- (Rs. One Crore Fifteen Lacs One Thousand Two Hundred Fifty only)** for disbursement to the grantee through electronic transfer. The expenditure involved is debitable to Major Head "2235" -Social Security and Welfare, 02-Social Welfare, 103-Women's Welfare, 73-Mission For Protection and Empowerment 73.05.35-Grants for Creation of Capital Assets (Plan) for Construction of Hostels for Working Women, under Demand No. 98, Ministry of Women and Child Development during 2018-2019.

7. This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 26281/JS&FA/2018 dated 30.08.2018. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.

8. Entry has been made in the GIA Register at Sl. No. 12.

9. The organization will submit Utilization Certificate of the Grant-in-aid by 04.05.2019.

10. It is requested that efforts may be made for awareness generation with regard to prevention and controlling HIV/AIDS amongst the beneficiaries.
