Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Women's Agency for Development Activities, Manipur** - Release of second instalment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 1,62,79,065/- (Rupees One Crore Sixty Two Lacs Seventy Nine Thousand Sixty Five only) as Central Government's share for construction of a Working Women's Hostel for **50 working women** and Day Care Centre for **20 children** at Bishnupur Ward No. 4, Bishnupur District, Manipur. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 2,17,05,420/- (Rupees Two Crore Seventeen Lakh Five Thousand Four Hundred Twenty only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Women's Agency for Development Activities, Manipur** of a sum of **Rs. 64,66,769/-** (Rupees Sixty Four Lacs Sixty Six Thousand Seven Hundred Sixty Nine only) being the **second instalment** of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

5. It may be ensured that the funds earlier released have been effectively utilised and that the data and facts reported by the organisation relating to physical and financial performance are correct. The Institute/organisation shall submit a component-wise Statement of Expenditure and Utilization Certificate as per prescribed format (**GFR-19-A**), certifying the actual utilization of grants for the purpose for which it was sanctioned. The organisation should have the capacity to actually spend the balance from the previous years and the releases during the current year.

6. The first instalment was released to the organization of Rs. 81,39,532/- vide Ministry's sanction dated 11.09.2017.
