A meeting of the Project Sanctioning Committee(PSC) for UJJAWALA - A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation and Reintegration of victims of Trafficking for Commercial Sexual Exploitation was held on **12.08.2013 at 11.30 a.m.** under the Chairpersonship of Secretary (Ministry of Women and Child Development), in Room No. 601, 'A' Wing, Shastri Bhawan, New Delhi. Additional Secretary in charge of the scheme (Smt. Ratna Prabha) and JS & FA were present besides other officers concerned.

2. In all, 31 proposals from 12 States - Andhra Pradesh, Arunachal Pradesh, Assam, Haryana, Maharashtra, Rajasthan, Uttar Pradesh, Uttrakhand, Gujarat, Manipur, Jharkhand and Chhattisgarh - were considered by the Project Sanctioning Committee (PSC). Out of the 31 proposals, the Committee approved 25 proposals, deferred 5 proposals and did not approve 1 proposal as per details given below:

6. The following decisions were also taken:

(i) The Rehabilitation component in respect of fresh proposals approved will be for a capacity of 50.

(ii) The project now sanctioned will be reviewed after completion of 1 ½ years for considering sanction of Re-integration and/or Repartition components to the organizations which have applied for these components.

(iii) Instead of asking the individual organizations to obtain license under section 21 of Immoral Traffic (Prevention) Act, 1956, the Ministry should write to the concerned State Governments informing them about sanction of P & R Home to the organization and advise them to issue necessary license. The same procedure may be followed in respect of past cases also.

(iv) All NGOs who have been sanctioned Ujjawala projects should sign up on NGO partnership system of the Planning Commission of India within a period of one month and inform the Ministry accordingly. Only after receipt of this information, fund will be released to the organization.

(v) Since maximum rent in respect of rehabilitation Home and Half Way Home is prescribed under the Scheme, no separate rent assessment certificate from State PWD should be insisted upon. Payment of rent may be regulated on the basis of Rend Deed.
