Subject: Minutes of the 18th Meeting of the Project Sanctioning Committee (PSC) on 'UJJAWALA – A comprehensive scheme for prevention of trafficking and rescue, rehabilitation and reintegration of victims of trafficking for commercial sexual exploitation'held on 14th December, 2012.

The 18th meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA' – A comprehensive scheme for prevention of trafficking and rescue, rehabilitation and reintegration of victims of trafficking for commercial sexual exploitation was held on 14thDecember, 2012 in Secretary (WCD)'s Chamber at ShastriBhawan, New Delhi. The proceedings were held through Video Conferencing with all the concerned States, except for Karnataka and Bihar, as the video conferencing facility was not available on the scheduled date and time in these states, and these 2 States were requested to be physically present for the PSC meeting. The representative from State Government of Karnataka was present in person is the PSC meeting. However the representative from State Government of Bihar was not present.

The PSC considered 20 project proposals received from the Non-Governmental Organizations, as recommended by the State Governments, from 7 States of Assam, Bihar, Karnataka, Manipur, Orissa, Rajasthan and Uttarakhand. Out of the 20 proposals, the Committee approved 11 proposals, deferred 4 proposals, and rejected 5 proposals as per details given below:

The list of proposals approved/deferred/rejected by the PSC is given at Annex-I. In respect of proposals approved, the amount sanctioned will be as per the schematic norms. However, for the organizations that have been given approval for Rehabilitation (Protective and Rehabilitative Homes) component, the number of beneficiaries for which the approval has been given is indicated in the 'Decision' column. Where the P&R Home is sanctioned for 25 beneficiaries, the admissible budget is as given in Annex-II.

The following general decision was taken in the meeting

 A Senior officer, at least of the level of Deputy Secretary/Director or Secretary should represent the State Government in the PSC meetings, whether in person or through video conferencing.

The following general decisions taken in the 16th and 17th Meetings of the PSC were re-iterated in the 18thmeeting:

- State Government should conduct regular monitoring on the progress of 'Ujjawala' Scheme to ensure effectiveness of grants received by the organizations.
- All State Governments should facilitate the process of issuing licenses to all sanctioned Ujjawala P&R Homes in their respective States under Section 21 of ITPA Act.
- Such organizations for which 4th year continuous grant for Ujjawala P&R
 Home has been approved, the Ministry would release the first instalment of
 the 4th year grant to begin with, but release of second instalment would be
 subject to receipt of the authenticated copy of licence for running protective
 home as per Section 21 of ITPA.
- All other organizations which are running Ujjawala P&R Home or have been sanctioned P&R Home in the recent PSC meetings, must obtain licence for running P&R Home from their respective State Governments by 31.10.2013.
 Subsequent grants would be subject to receipt of the authenticated copy of the licence for running protective home as per Section 21 of ITPA.
