
Subject: Minutes of 16th and 17th Meetings of the Project Sanctioning Committee (PSC) on UJJAWALA-A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation and Reintegration of Victims of Trafficking for Commercial Sexual Exploitation, on 18th and 19th October 2012 respectively.

16th and 17th meetings of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation and Reintegration of Victims of Trafficking for Commercial Sexual Exploitation was held on 18.10.2012 and 19.10.2012 respectively in Secretary(WCD)'s Chamber at Shastri Bhawan, New Delhi. The proceedings were held through Video Conferencing with all the concerned States except Chhattisgarh and Rajasthan. The representatives from Chhattisgarh and Rajasthan were present in person before the PSC as the video conferencing facility was not available on the scheduled date and time in their states. The PSC considered proposals received from the Non- Governmental Organizations, duly recommended by the State Governments.

On 18th October 2012, 20 proposals from 7 states of Assam, Andhra Pradesh, Gujarat, Haryana, Madhya Pradesh, Maharashtra, Uttar Pradesh and on 19th October 2012, 28 proposals from 6 states - Karnataka, Manipur, Mizoram, Orissa, Chhattisgarh and Rajasthan were considered by the Project Sanctioning Committee.

Out of the 48 proposals, the Committee approved 28 proposals, deferred 16 proposals, withheld decision on 1 proposal, and rejected 3 proposals as per details given below:

The list of proposals approved/deferred/rejected by the PSC is given at Annex- I. In respect of proposals approved, the amount sanctioned will be as per the schematic norms. However, for the organizations that have been given approval for Rehabilitation (Protective and Rehabilitative Homes) component, the number of beneficiaries for which the approval is given is indicated in the Decisions column. Where the Home is sanctioned for 25 beneficiaries, the admissible budget is attached at Annex- II.

The following general decisions were taken in the meeting

- State Governments should conduct regular monitoring on the progress of Ujjawala scheme to ensure effectiveness of grants received by the organization.
- All State Governments should facilitate the process of issuing licenses to all sanctioned Ujjawala P&R Homes in their respective States under Section 21 of ITPA Act.
- Such organizations for which 4th year continuous grant for Ujjawala P&R Home has been approved, the Ministry would release the first installment for the 4th year grant to begin with, but release of second installment is subject to receipt of the authenticated copy of license for running protective home as per Section 21 of ITPA.
- All other organizations which are running Ujjawala P&R home or has been sanctioned for P&R home in the above PSC meetings, must obtain license for running P&R Home from their respective State Governments within one year, i. e. <u>by 31.10.2013</u>. Subsequent grants would be subject to receipt of the authenticated copy of license for running protective home as per Section 21 of ITPA.
- The projects in the 3rd year of implementation should be evaluated well in advance for consideration of their continuation in the 4th year.
