A meeting of the Project Sanctioning Committee(PSC) for UJJAWALA - A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation and Reintegration of victims of Trafficking for Commercial Sexual Exploitation which was earlier scheduled on 22.11.2013 was held at 2.45 p.m. on 02.12.2013 under the Chairpersonship of Additional secretary(Smt. K. Ratna Prabha), Ministry of Women and Child Development in Room No.616, A Wing, Shastri Bhawan, New Delhi. Smt. Sariata Mittal, JS&FA; Sh. G. Devnani, Deputy Secretary; US(CP) and SO(CP) were present.

2. In all, 61 proposals from 13 States - Andhra Pradesh, Arunachal Pradesh, Assam, Bihar, Gujarat, Jharkhand, Karnataka, Maharashtra, Manipur, Orissa, Rajasthan, Tamil Nadu, and Uttar Pradesh - were considered by the Project Sanctioning Committee (PSC). Out of the 61 proposals, the Committee approved 22 proposals, deferred 34 proposals and did not approve 5 proposals as per details given below:

4. The following decisions were also taken:

(i) The Rehabilitation component in respect of fresh projects approved will be for a capacity of 25.

(ii) The projects now sanctioned will be reviewed after completion of 1 ½ years for considering sanction of Re-integration and/or Repartition components to the organizations which have applied for these components.

(iii) The Ministry should write to the concerned State Governments informing them about sanction of P & R Home to the organization and advise them to issue necessary license under section 21 of Immoral Traffic (Prevention) Act, 1956.

(iv) All NGOs who have been sanctioned Ujjawala projects should sign up on NGO partnership system of the Planning Commission of India within period of one month and inform the Ministry accordingly. Only after receipt of this information, fund will be released to the organization.

(v) Since maximum rent in respect of Rehabilitation Home and Half Way Home is prescribed under the Scheme, no separate rent assessment certificate from State PWD should be insisted upon. Payment of rent may be regulated on the basis of Rend Deed.
