Subject:- Minutes of the 6th meeting of the Project Sanctioning Committee on **UJJAWALA- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation, Re-Integration and Repatriation of Victims of Trafficking** for commercial sexual exploitation.

A meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- a comprehensive scheme to combat trafficking, was held on 22.5.2010 at 11.00 A.M., under the Chairmanship of Secretary (MWCD), in Committee Room No. 116, National Institute of Public Co-operation and Child Development(NIPCCD), 5, Siri Institutional area, Hauz Khas, New Delhi-16. The PSC considered proposals received from the Non- Governmental Organisations, duly recommended by the State Governments. A list of participants is enclosed at Annexure -I.

2. In all, 28 proposals from 2 States of Orissa and Karnataka were considered by the Project Sanctioning Committee, of which the Committee approved 4 proposals, deferred 2 and rejected 22 proposals as per details given below:

3. It was also decided that the State Government should:-

- (i) Periodically review the functioning and performance of all Ujjawala projects being implemented in State and inform MWCD of the outcome of such review.

- (ii) Ensure that all organizations which are given sanctions for Rehabilitation and Re-integration Homes send photo identities of all the beneficiaries in such Homes. These photo identities should be continually updated.
- (iii) Ensure that the NGOs furnish a quarterly progress report to MWCD.
