Subject:- Minutes of the 10<sup>th</sup> meeting of the Project Sanctioning Committee on UJJAWALA- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation, Re-Integration and Repatriation of Victims of Trafficking for Commercial Sexual exploitation.

A meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- a comprehensive scheme to combat trafficking was held on 08.12.2010 at 11.00 A.M. in Room No. 309, 'B' Wing, Shastri Bhawan, New Delhi. The PSC considered proposals received from the Non- Governmental Organizations, duly recommended by the State Governments. A list of participants is enclosed at Annex-I.

2. In all, 34 proposals from 3 States of Orissa, Maharashtra and Uttar Pradesh were considered by the Project Sanctioning Committee. Of these the Committee approved 11 proposals, deferred 3 and rejected 20 proposals as per details given below:
