Subject:- Minutes of the 5th meeting of the Project Sanctioning Committee on **UJJAWALA- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation, Re-Integration and Repatriation of Victims of Trafficking** for commercial sexual exploitation.

A meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- a comprehensive scheme to combat trafficking, was held over two days, on 12.1.2010 at 12.00 Noon and on 13.1.2010 at 11.00 A.M., under the Chairmanship of Secretary (MWCD), in Room No. 601, 'A' Wing, Shastri Bhavan, New Delhi. The PSC considered proposals received from the Non- Governmental Organizations, duly recommended by the State Governments. A list of participants is enclosed at Annexure-I.

2. In all, 58 proposals from 10 States were considered by the Project Sanctioning Committee, over the two days, of which the Committee approved 23 proposals, deferred 18 and rejected 17 proposals as per details given below:
