Subject:- Minutes of the 9th meeting of the Project Sanctioning Committee on UJJAWALA- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation, Re-Integration and Repatriation of Victims of Trafficking for commercial sexual exploitation.

A meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- a comprehensive scheme to combat trafficking, was held on 10.11.2010 at 11.00 A.M., under the Chairmanship of Secretary (Ministry of Women & Child Development), in Room No. 601, 'A' Wing, Shastri Bhawan, New Delhi. The PSC considered proposals received from the Non- Governmental Organizations, duly recommended by the State Governments. A list of participants is enclosed at Annex-I.

2. In all, 35 proposals from 6 States of Gujarat, Madhya Pradesh, Punjab, Meghalaya, Jharkhand and Andhra Pradesh were considered by the Project Sanctioning Committee. Of these the Committee approved 7 proposals, deferred 8 and rejected 20 proposals as per details given below:

- (iii) Ensure that the NGOs furnish a quarterly progress report to MWCD.
