Subject:- Minutes of the 11<sup>th</sup> meeting of the Project Sanctioning Committee on UJJAWALA- A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation, Re-Integration and Repatriation of Victims of Trafficking for Commercial Sexual exploitation.

A meeting of the Project Sanctioning Committee (PSC) for 'UJJAWALA'- a comprehensive scheme to combat trafficking was held on 20.05.2011 at 11.00 A.M. in Room No. 309, 'B' Wing, Shastri Bhawan, New Delhi. The PSC considered proposals received from the Non- Governmental Organizations, duly recommended by the State Governments. A list of participants is enclosed at Annex-I.

2. In all, 60 proposals from 12 States of Andhra Pradesh, Jammu & Kashmir, Tripura, Gujarat, West Bengal, Maharashtra, Rajasthan, Tamil Nadu, Arunachal Pradesh, Karnataka, Bihar and Assam were considered by the Project Sanctioning Committee. Of these the Committee approved 7 proposals, deferred 21 proposals and rejected 32 proposals as per details given below:
