Subject: Release of recurring grant-in-aid of Rs. 2,64,93,939/ (Rupees Two crore Sixty Four Lakhs Ninety Three Thousand Nine Hundred Thirty Nine only) to UT Administration of Puducherry for running crèches under the National Crèche Scheme for the Children of Working Mothers– regarding.

Madam/Sir,

I am directed to convey the sanction of President of India to the payment of Rs. 2,64,93,939/ (Rupees Two crore sixty four lakhs Ninety three thousand Nine hundred thirty Nine only) to the UT Administration of Puducherry for 2nd, 3rd & 4th quarter of 2017-18, 2nd, 3rd & 4th quarter of 2018-19 and 1st and 2nd quarter of 2019-20 as grant-in-aid (90% Govt's Share) for running crèches under National Crèche Scheme for Children of Working Mothers as per following details:-

2. The fund sharing pattern between the Central Government and organization/institution running the crèches will be in the ratio 90:10 and sanction of funds is subject to the following conditions:

- The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- The State/UTs/NGO shall also be required to contribute their share for implementation of the National Crèche Scheme.
- Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments/UT Admn. shall ensure that the NGOs running the crèches are registered in the NGO-PS portal and have furnished details of Unique ID from NGO-PS portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

3. The grant is further subject to condition that the UT Administration of Puducherry will maintain separate records of expenditure incurred for implementation of National Creche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

4. Details of progress of expenditure on National Crèche Scheme form 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry of work out the entitlement of Central assistance of each State/UT Administration.

5. The expenditure of Rs.2,64,93,939/- (Rupees Two Crore Sixty Four Lakhs Ninety Three Thousand Nine Hundred Thirty Nine Only) is debitible to the 3602 -Grants-in-aid to Union Territory Governments (Major Head), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 47 ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.99, Ministry of Women & Child Development 2019-20 (Plan).

6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the UT Administration be arranged through Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.


