2.10 &	Pace of implementation of the Scheme of Women Helpline, Swadhar Greh, Ujjawala and Working Women Hostels needs to be increases. As per the information made available by the Ministry, during the last three years, only 48199 and 18525 women have benefitted under Swadhar Greh and Ujjawala Scheme and 72288 women have taken benefit of WWH Scheme. Perhaps people are not aware of the schemes of the Ministry. The Committee desires that wide publicity should be given to these schemes so that more and more women in need may take benefit of the schemes meant for them. The Committee also finds that the second instalment of the grant for the	State Governments are required to raise awareness about availability of Ujjawala projects under monitoring and IEC (Information Education and Communication) activities, target group of beneficiaries and various facilities provided there under. Each implementing agency also disseminates information about the Ujjawala project to the people though various available modes. State Governments/Union Territories Administrations are regularly contacted over telephone, e-mails and letters to furnish the required documents for further release of grant. Till now, grant has been
