**Subject: Fixation of uniform rates of honorarium to ASHA/AWW for filling up online form of Pradhan Mantri Matru Vandana Yojana (PMMVY)**

Madam/Sir,

I am directed to refer to the subject mentioned above and to say that under the new URL for Pradhan Mantri Matru Vandana Yojana (PMMVY) portal (<https://pmmvy.nic.in>) registration of beneficiaries of PMMVY only in online mode has been made functional. Accordingly, all States/UTs have been advised to start registration of PMMVY beneficiaries on the new PMMVY portal only. The online registration is aimed to maximize the use of IT for smooth and fast process and to reduce paper work. The online registration would be done by the Anganwadi Worker/ASHA for the beneficiaries. In order to incentivise their efforts for online registration of PMMVY beneficiaries and with a view to ensuring uniform rates of honorarium across the country amongst the ASHA/Anganwadi Workers, Competent Authority in the Ministry has decided following rates of honorarium to AWW/ASHA:-

In the case of self-registration by the beneficiaries, Rs. 150/- would be given to ASHA/AWW for field level verification within a period of 30 days from the date of self-registration. Beyond 30 days, incentive of Rs. 50/- would be given to the ASHA/AWW for field level verification.
