Subject: Scheme of Assistance to Voluntary Organisation for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to "Abhiyan", Bilaspur, Chhattisgarh at Plot No. 20, Khasra No. 175/4, Chantidih, Tehsil Bilaspur, Chhattisgarh – Release of final instalment –reg.

Madam/Sir,

In continuation of this Ministry's sanction letters of even number dated 28.02.2011 & 24.10.2013, I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 54,56,250/- (Rupees Fifty Four Lakh Fifty Six Thousand Two Hundred and Fifty only) as Central Government Share for construction of 60 Working Women & 30 Children at Plot No. 20, Khasra No. 175/4, Chantidih, Tehsil Bilaspur, Chhattisgarh. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 72,75,000/- (Rupees Seventy Two Lakh and Seventy Five Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, directed to convey the sanction of the President to the payment to Secretary, "Abhiyan", Bilaspur, Chhattisgarh of a sum of Rs. 5,45,625/- (Rupees Five Lakh Forty Five Thousand Six Hundred and Twenty Five only) being the total amount of final instalment of the grant for construction of working women hostel which will be used as a hostel for working women.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the documents submitted by the organization and therefore, no separate Utilisation Certificate will be issued for this sanctioned amount. However, in default the amount would be recovered as arrears of land revenue.

4. It may be ensured that the funds earlier released have been effectively utilised and that the data and facts reported by the organisation relating to physical and financial performance are correct.

5. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

10. The UC of the previous grant in aid released under WWH scheme is attached herewith.




