Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Aghiyilito Multipurpose Co-operative Society Ltd., Nagaland** - Release of **final** instalment.

Sir,

In continuation of this Ministry's sanction letter of even number dated 25.05.2018, I am directed to say that the Government of India had sanctioned a non-recurring grant of Rs. 3,21,35,897/- (Rupees Three Crore Twenty One Lacs Thirty Five Thousand Eight Hundred Ninety Seven only) as Central Government's share for construction of a Working Women's Hostel for **100 working women** and Day Care Centre for **30 children** at Atoizu Town, Zunheboto, Nagaland. The grant for construction of hostel building represents 75% of the total approved cost of Rs. 4,28,47,863/- (Rupees Four Crore Twenty Eight Lakh Forty Seven Thousand Eight Hundred Sixty Three only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the approved cost, 75% of the difference between the approved cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the organisation **Aghiyilito Multipurpose Co-operative Society Ltd., Nagaland** of a sum of **Rs. 39,63,589/-** (Rupees Thirty Nine Lacs Sixty Three Thousand Five Hundred Eighty Nine only) being Rs. 32,13,589/- as the **final instalment** of the grant for the construction of the building and Rs. 7,50,000/- as grant for furniture & furnishings for 100 women @ Rs. 7500/- per women on reimbursement basis.

3. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.
