Sir,

I am directed to say that the Government of India has sanctioned a nonrecurring grant of Rs. 1,71,93,000/- (Rupees One Crore Seventy One Lakh Ninety Three Thousand only) as Central Government's share for construction of a Working Women's Hostel for 100 **working women** and Day Care Centre for 50 **children** at **Tiruchanur, Tirupathi Rural, Chittor, Andhra Pradesh**. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 2,29,24,000/-(Rupees Two Crore Twenty Nine Lakh Twenty Four Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Andhra Pradesh Women's Co-operative Finance Corporation Limited**, **Hyderabad** of a sum of Rs. 61,70,707/- (Rs. Sixty One Lacs Seventy Thousand Seven Hundred Seven only) being the **balance amount of 1st installment** of the grant for the construction of the building which will be used as a hostel for working women.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this installment along with agency's share immediately after the grant is expended. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
