Sir,

In continuation of the Ministry's sanction dated 31.12.2014, I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 1,12,50,000/- (Rupees One Crore Twelve Lakh Fifty Thousand only) as Central Government's share for construction of a Working Women's Hostel for 52 working women and Day Care Centre for children at plot/ survey No. 239/229, Mudigere, Chikkamagalur District, Karnataka. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 1,50,00,000/- (Rupees One Crore Fifty Lakh only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

- 2. I am, accordingly, to convey the sanction of the President to the payment to Ashraya Samajika Seva Samasthe, Karnataka of a sum of Rs. 15,15,000/- (Rupees Fifteen Lacs Fifteen Thousand only) being the final instalment of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed within extended time from the date of sanction of the first instalment.
- 3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 4. It may be ensured that the funds earlier released have been effectively utilised and that the data and facts reported by the organisation relating to physical and financial performance are correct. The Institute/organisation shall submit a component-wise Statement of Expenditure and Utilization Certificate as per prescribed format (GFR-19-A), certifying the actual utilization of grants for the purpose for which it was sanctioned. The organisation should have the capacity to actually spend the balance from the previous years and the releases during the current year.
- 5. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG** (**DPC**) **Act**, **1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236** (1) of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

- 6. The first instalment of ₹ 56,25,000/- (50% of GOI) and the second instalment ₹ 45,00,000/- (40% of GOI) has been released vide this Ministry's sanction dated 13.12.2013 and 31.12.2014 respectively.
- 7. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount of Rs. 15,15,000/- (Rupees Fifteen Lacs Fifteen Thousand only) for disbursement to the grantee through electronic transfer.
