
Sir,

In continuation of this Ministry's sanction letter of even number dated 24.05.2018, I am directed to say that the Government of India has sanctioned a nonrecurring grant of Rs. 2,73,51,326/- (Rupees Two Crore Seventy Three Lacs Fifty One Thousand Three Hundred Twenty Six only) as Central Government's share for construction of a Working Women's Hostel for **100 working women** and Day Care Centre for **30 children** at Nuiland Town, Niuland Sub-division, Dimapur, Nagaland. The grant for construction of hostel building represents 75% of the total approved cost of Rs. 3,64,68,435/- (Rupees Three Crore Sixty Four Lakh Sixty Eight Thousand Four Hundred Thirty Five only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the approved cost, 75% of the difference between the approved cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the organisation **Chophi Welfare Society**, **Nagaland** of a sum of **Rs. 34,37,350/**-(Rupees Thirty Four Lacs Thirty Seven Thousand Three Hundred Fifty only) being Rs. 26,87,350/- as the **final instalment** of the grant for the construction of the building and Rs. 7,50,000/- as grant for furniture & furnishings for 100 women @ Rs. 7500/- per women on reimbursement basis.

3. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC)** Act, 1971 and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236** (1) of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

4. The first instalment of Rs. 1,36,75,663/- (50% of GOI) and second instalment of Rs. 1,09,40,530/- (40% of GOI) had been released to the organisation vide this Ministry's dated 09.10.2017 and 24.05.2018 respectively.
