Subject: Release of Second instalment to Directorate of Women & Child Development, Department of Social Justice & Empowerment, Govt. of Himachal Pradesh for Construction of Working Women Hostel for 20 Working Women with Day Care Centre for 30 Children at Ponta Sahib, Distt. Sirmour, Himachal Pradesh -reg.

Madam/Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 2,79,66,750/- (Rupees Two Crore Seventy Nine Lakh Sixty Six Thousand Seven Hundred and Fifty only) as Central Government's share for construction of a Working Women's Hostel for 20 working women and Day Care Centre for 30 children at Rampur Ghat, Ponta Sahib, Distt. Sirmour, Himachal Pradesh. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 3,72,89,000/- (Rupees Three Crore Seventy Two Lakh and Eighty Nine Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

- I am, accordingly, to convey the sanction of the President to the payment to the Directorate of Women & Child Development, Department of Social Justice & Empowerment, Govt. of Himachal Pradesh of a sum of Rs. 1,11,86,700/- (Rs. One Crore Eleven Lakh Eighty Six Thousand and Seven Hundred only) being the Second installment (40% of the Central Share) of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed within 24 months from the date of sanction of the first instalment.
- The Working Women Hostel is a sub-scheme of the Centrally Sponsored Umbrella Scheme "Mission for Protection & Empowerment for Women". In the above release, the Central Government contribution has been calculated as 75:25 ratio and sanction of funds is subject to the following conditions;

- (i) The amount of the grant will have to be utilised for all components under the scheme as per the schematic norms.
- (ii) The implementing agency shall also be required to contribute their share for implementation of the Working Women Hostel Scheme.
- 4. The grant is further subject to condition that the State Government will maintain separate records of expenditure incurred for implementation of Working Women Hostel and furnish separate Statement of Expenditure and Utilization Certificate duly indicating the Physical Progress Report along with agency's share within <u>Six months</u> of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 5. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under Rule 236 (1) of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.
- 6. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will revert to the Central Government.
- 7. The expenditure involved is debitable to Major Head "3601"-Grant-in-aid to State Governments, 06-Centrally Sponsored Schemes (Sub Major Head), 101 -Central Assistance/Share (Minor Head), 48-Mission For Protection and Empowerment 05-Working Women Hostel (Detailed Head), 35-Grants for Creation of Capital Assets (Object Head) under Demand No. 99, Ministry of Women and Child Development during 2019-20.
- 8. The amount of grant-in-aid is finally adjustable in the books of the Principal Accounts Office, Ministry of Women & Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of 'Women & Child Development, Shastri Bhawan, 'D' Wing, Ground Floor, New Delhi.
- 9. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principals of the Scheme approved by the Competent Authority.
- 10. The sanction issues with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 1219/AS&FA/2019 dated 20.11.2019.
- 11. As per Rule 230(8) of GFR 2017, any interest earned against Grant-in-Aid should be remitted to the Consolidated Fund of India through a Cheque/Demand Draft made in favour of "Pay & Account Officer, Ministry of Women & Child Development."
