Kannur, Kerala- **Release of withheld amount of Second instalment.**

Sir,

In continuation of this Ministry's sanction letter of even number dated 17-03-2011 on the subject mentioned above, I am directed to convey the sanction of the President for the release of a further sum of **Rs. 1,47,98,182 /- (Rupees one crore forty seven lakh ninety eight thousand one hundred and eighty two only out of 2,11,99,600/- sanctioned for the Second installment of the grant out of a non-recurring grant of Rs.529.99/- (Rupees Five Crore Twenty Nine Lakhs and Ninety Nine Thousand)** as Central Government's share for construction of a Working Women's Hostel for 660 **working women and Day Care Centre for 45 children at Industrial growth centre of KSIDC at Valiyavelicham, Koothuparamba, Distt. Kannur, Kerala by Kerala State Industrial Development Corporation Ltd. (KSIDC), Thiruvananthapuram.** An amount of Rs. 64,01,418/- (Rupees Sixty four lakhs one thousand four hundred and eighteen only) has already been released towards part payment of second instalment vide this office sanction letter of even no. dated: 25-03-2013 The grant of Rs. 529.99 cr. represents 75% of the total estimated cost of Rs. 706.66 lakhs (Rupees Seven Crore Six Lakh and Sixty Six Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimate cost, 75% of the difference between the estimated cost and the actual expenditure will have to be refunded by the organization to the Ministry. The construction of the Hostel will be completed in 24 months from the date of sanction of the first installment.

2. The grant shall be subject to further terms and conditions as laid down in the Scheme. The organization will furnish audited accounts for the utilization of the amount of this installment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.


3. The accounts for the above grants will be subject to test check by the Controller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

The expenditure involved is debitable to Major Head "2235" -Social Security and Welfare, 02-Social Welfare, 103-Women's Welfare, 03-Assistance to Voluntary Organisations for Hostels for Working Women, 03.00.35-Grant-in-aid (Plan) under Demand No. 105, Ministry of Women and Child Development during 2013-2014.

This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy.No. 549/JS&FA/2013 dated: 19.06.2013. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.
7. Entry has been made in the GIA Register at S.No. **03**.
8. The organization will submit Utilization Certificate of the Grant-in-aid by 28-02-2014.
9. It is requested that efforts may be made for awareness generation with regard to prevention and controlling HIV/AIDS amongst the beneficiaries.
