
In continuation of this Ministry's earlier sanction letter of even number dated 25.06.2012 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of Rs. 20,66,829/- (Rupees Twenty Lakh Sixty Six Thousand Eight Hundred Twenty Nine only) being the **third & final** instalment of grant out of a non-recurring grant of Rs. 1,12,93,281/- (Rupees One Crore Twelve Lakh Ninty Three Thousand Two Hundred Eighty One only) as Central Government's share for construction of a Working Women's Hostel for 125 working women at **Sy. No. 33/2 and 33/3 in Pullazhi Village, Trichur, Kerala** by **Kerala State Housing Board, Santhi Nagar, Thiruvananthapuram**.

2. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount**.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.




