Sir,

In continuation of this Ministry's earlier sanction letter of even number dated 20.09.2010 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of Rs. 5,31,958/- (Rupees Five Lakh Thirty One Thousand Nine Hundred Fifty Eight only) being reimbursement towards the **fourth & final** instalment of grant out of a non-recurring grant of Rs. 53,19,562/- (Rupees Fifty Three Lakh Nineteen Thousand Five Hundred Sixty Two only) as Central Government's share for construction of a Working Women's Hostel for 100 working women at **Pangei, Imphal East Under Patta No. 13/254 (New) Dag No. 55**.


2. The grant shall be subject to further terms and conditions as laid down in the scheme. This fourth & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount**.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.


