That the Government of India has sanctioned a non-recurring grant of Rs. 1,50,94,500/- (Rupees One Crore Fifty Lakh Ninety Four Thousand Five Hundred only) as Central Government's share for construction of a Working Women's Hostel for **100 Working Women** with day Care Centre for **25 pre-School Children** at Yairipok, Thoubal District, Manipur. The grant for construction of this hostel building represents 75% of the total estimated cost of Rs. 2,01,26,000/- (Rupees Two Crore One Lakh Twenty Six Thousand only) as admitted for construction of the subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated expenditure is required to have to be refunded by the organization to the Ministry.




