Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Nagaland Handloom and Handicraft Development Corporation Ltd.**, Dimapur, Nagaland at Old Town, Zunhebotto Distt. Nagaland - Release of **final instalment-reg.**

Sir,

In continuation of this Ministry's sanction letter of even number dated 06.07.2015, I am directed to say that the Government of India had sanctioned a non-recurring grant of Rs. 3,35,52,000/- (Rupees Three Crore Thirty Five Lakh Fifty Two Thousand only) as Central Government's share for construction of a Working Women's Hostel for **100 Working Women** with day Care Centre for **30 pre-School Children** at Old Town, Zunhebotto Distt. Nagaland. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 4,47,36,000/- (Rupees Four Crore Forty Seven Lakh Thirty Six Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Nagaland Handloom and Handicraft Development Corporation Ltd., Dimapur, Nagaland** of a sum of **Rs. 41,05,200/-** (Rupees Forty One Lacs Five Thousand Two Hundred only) being Rs. 33,55,200/- as the **final instalment** of the grant for the construction of the building and Rs. 7,50,000/- as grant for furniture & furnishings for 100 women @ Rs. 7500/- per women on reimbursement basis.

3. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

4. The first instalment of Rs. 1,67,76,000/- (50% of GOI) and second instalment of Rs.1,34,20,800/- (40% of GOI) had been released to the organisation vide this Ministry's dated 30.12.2013 and 06.07.2015 respectively.
