- 2. The above mentioned sanction is subject to the following conditions:
  - The grant-in-aid released are to be utilized strictly as per the schematic norms of the [a] Programme and Programme implementation Guidelines of Pradhan Mantri Matru Vandana Yojana.
  - [b] The State Government will transfer corresponding State share to the Escrow Account of the State Government.

- 3. The State/UT Government will furnish Utilisation Certificate in respect of the grants-in-aid released as per the provisions contained in GFR, 2017. Further, the State/UT Government will maintain separate records of expenditure incurred for implementation of Pradhan Mantri Matru Vandana Yojana (PMMVY) and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure for the period 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July, for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October, for the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and for 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of the State Government.
- 4. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole. The grant-in-aid to the State/UT Government may be directly transferred through e-payment to the *Escrow* Bank Account of the above-mentioned State/UT Government.
