Sixteen Lacs Sixty Thousand Nine Hundred Seventeen only)** including non-recurring grand of Rs. 7,50,000/- incurred towards the purchase of furniture and furnishing items, being reimbursement towards the **fourth & final** instalment of grant out of a non-recurring grant of Rs. 98,59,146/- (Rupees Ninety Eight Lakh Fifty Nine Thousand One Hundred Forty Six only) as Central Government's share for construction of a Working Women's Hostel for 100 working women at **Patta No. 21/ 134/ 712-713, Dag No. 1027 and 1027 (B), Kongkham, Nambol, Bishnupur District, Manipur.**






