Sir,

In continuation of this Ministry's sanction letter of even number dated 16.12.2013, I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 4,75,58,250/- (Rupees Four Crore Seventy Five Lakh Fifty Eight Thousand Two Hundred Fifty only) as Central Government's share for construction of a Working Women's Hostel for 159 working women and Day Care Centre for 25 children at 192/2, 193/8, 328/9 Chevayoor, Kohikode, Kerala. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 6,34,11,000/- (Rupees Six Crore Thirty Four Lakh Eleven Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

- 2. I am, accordingly, directed to convey the sanction of the President to the payment to the **Kerala State Housing Board** of a sum of **Rs. 1, 90,23,200/- (Rupees One Crore Ninety Lakh Twenty Three Thousand Two Hundred only)** being the **second instalment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.
- 3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
