In continuation of this Ministry's earlier sanction letter number 4(11)-2/2013-WH dated 24.09.2015 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of **Rs. 29,10,000/- (Rs. Twenty Nine Lacs Ten Thousand only)** including non-recurring grant of Rs. 5,55,000/- incurred towards the purchase of furniture and furnishing items, being reimbursement towards the **third & final** instalment of grant as Central Government's share for construction of a Working Women's Hostel for 74 **working women** at **Muttom Village, Idukki District, Kerala**.

2. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount.**

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
