
In continuation of this Ministry's earlier sanction letter number 4(11)-2/2010-WH dated 24.06.2013 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of **Rs. 97,99,900/- (Rs. Ninety Seven Lacs Ninety Nine Thousand Nine Hundred only)** including non-recurring grant of Rs. 45,00,000/- incurred towards the purchase of furniture and furnishing items, being reimbursement towards the **third & final** instalment of grant out of a non-recurring grant of Rs. 5,29,99,000/- (Rupees Five Crore Twenty Nine Lakh Ninety Nine Thousand only) as Central Government's share for construction of a Working Women's Hostel for 600 **working women** and Day Care Centre for **45 children** at **Industrial growth centre of KSIDC at Valiyavelicham, Koothuparamba, Distt. Kannur, Kerala.**

2. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount.**

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

4. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount for disbursement to the grantee through electronic transfer.


