Subject : Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Longli Lenden Welfare Society, Nagaland** at Tuli Town, Mokokchung District, Nagaland - Release of first instalment.

Sir,


I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 5,33,88,450/- (Rupees Five Crore Thirty Three Lakh Eighty Eight Thousand Four Hundred Fifty only) as Central Government's share for construction of a Working Women's Hostel for 80 working women and Day Care Centre for 20 children to **Longli Lenden Welfare Society, Nagaland** at Tuli Town, Mokokchung District, Nagaland. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 7,11,84,600/- (Rupees Seven Crore Eleven Lakh Eighty Four Thousand Six Hundred only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Longli Lenden Welfare Society, Nagaland** of a sum of Rs. 2,66,94,225/- (Rs. Two Crore Sixty Six Lakh Ninety Four Thousand Two Hundred Twenty Five only) being the **first instalment** of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. Further, the organisation will not alienate the property to any third party. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within eight months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.



9. The organization will submit Utilization Certificate of the Grant-in-aid by 21-10-2017.


10. It is requested that efforts may be made for awareness generation with regard to prevention and controlling HIV/AIDS amongst the beneficiaries.
