Subject : Scheme of Assistance for Construction of Hostel Building for Working Women - Grants-in-aid to National Centre for Rural Development, Pune - Release of Second installment.


Sir,

In continuation of this Ministry's sanction letter of even number dated 27.11.2015, I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 3,63,84,282/- (Rupees Three Crore Sixty Three Lakh Eighty Four Thousand Two Hundred Eighty Two only) as Central Government's share for construction of a Working Women's Hostel for **100 Working Women at Plot No. 72-D, Sector 11, Kharghar, Navi Mumbai**. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 4,85,12,378/- (Rupees Four Crore Eighty Five Lakh Twelve Thousand Three Hundred Seventy Eight only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **National Centre for Rural Development, Pune of a sum of Rs. 1,45,53,713/- (Rs. One Crore Forty Five Lacs Fifty Three Thousand Seven Hundred Thirteen only)** being the **second instalment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within nine months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. **11877/JS & FA dated 18.12.2016**. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.

9. The organization will submit Utilization Certificate of the Grant-in-aid by 26-11-2017.
