Subject : Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Pune Cantonment Board, Pune** at Pune Cantonment Board, Pune, Maharashtra - Release of first installment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 3,88,89,710/- (Rupees Three Crore Eighty Eight Lakh Eighty Nine Thousand Seven Hundred Ten only) as Central Government's share for construction working women hostel construction of additional block of a Working Women's Hostel for **96 Working Women** and Day Care Centre for 25 children at Pune Cantonment Board, Pune. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 5,18,44,947/- (Rupees Five Crore Eighteen Lakh Forty Four Thousand Nine Hundred Forty Seven only) as admitted for construction working women hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Pune Cantonment Board, Pune** of a sum of **Rs. 1,94,41,855/- (Rs. One Crore Ninety Four Lacs Forty One Thousand Eight Hundred Fifty Five only)** being the **first installment** of the grant for expansion of existing working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this installment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

5. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount for disbursement to the grantee through electronic transfer. The bank details of **Pune Cantonment Board, Pune** is as under:-


