
Sir,

In supersession of this Ministry's earlier sanction letter number 4(11)-1/2011-WH dated 29.03.2016 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of **Rs. 14,85,000/- (Rs. (Rs. Fourteen Lacs Eighty Five Thousand only)** including non-recurring grant of Rs. 6,00,000/- incurred towards the purchase of furniture and furnishing items, being reimbursement towards the **third & final** instalment of grant out of a non-recurring grant of Rs. 94,50,000/- (Rupees Ninety Four Lakh Fifty Thousand only) as Central Government's share for construction of a Working Women's Hostel for **80 working women** and Day Care Centre for **20 children** at **Sy. No.161/1, Idukki Village, Vanchikkavala, Idukki Distt, Kerala**.

2. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount**.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.




