Subject : Scheme of Assistance for Construction of Hostel Building for Working Women Grants-in-aid to **Sharon Welfare Agency, Chumukedima Distt. Dimapur, Nagaland** at Chandamari Colony, Kohima, Nagaland - Release of second instalment.

Sir,

In continuation of this Ministry's sanction letter of even number dated 24.10.2014, I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. Rs. 1,17,06,483/- (Rupees One Crore Seventeen Lakh Six Thousand Four Hundred Eighty Three only) to Sharon Welfare Agency, Chumukedima Distt. Dimapur, Nagaland as Central Government's share for construction of a Working Women's Hostel for **60 Working Women** at Chandamari Colony, Kohima, Nagaland. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 1,56,08,644/- (Rupees One Crore Fifty Six Lakh Eight Thousand Six Hundred Forty Four only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, directed to convey the sanction of the President to the payment to the **Sharon Welfare Agency, Chumukedima Distt. Dimapur, Nagaland** of a sum of Rs. 46,82,593/- (Rupees Forty Six Lakh Eighty Two Thousand Five Hundred Ninety Three only) being the **second instalment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. Further, the organisation will not alienate the property to any third party. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
