Subject: Scheme of Assistance to **Eight Brothers Social Welfare Society, Assam** for running hostel in Rented Premises at Plot No. 50, Survery No. 561, Usha Nagar, Kamarchubu, Sonitpur, Assam for Working Women with Day Care Centre for Children - Release of **second** instalment.

Sir,


In continuation of this Ministry's sanction dated 27.9.2017, I am directed to say that the Government of India has approved the proposal of **Eight Brothers Social Welfare Society, Assam** for running of Working Women Hostel in the rented building at Plot No. 50, Survery No. 561, Usha Nagar, Kamarchubu, Sonitpur, Assam for 30 working women. Monthly rent of Rs. 31,168/- (Rs. Thirty One Thousand One Hundred Sixty Eight only) has been approved for hiring of hostel building for working women subject to the condition that in case the actual expenditure on this project is less than the approved rent, the difference between the approved rent and the actual expenditure will have to be refunded by the organization to the Ministry. The approval is as follows:

(i)	Location	:	Plot No. 50, Survery No. 561, Usha Nagar, Kamarchubu, Sonitpur, Assam.
(ii)	Area	:	1247.26 Sq. mt.
(iii)	Accommodation	:	30 working women and 25 Children
(iv)	Rent approved	:	Rs. 31,168/- per month
(v)	Duration	:	2 Years

2. I am, accordingly, to convey the sanction of the President to the payment to the **Eight Brothers Social Welfare Society, Assam** of a sum of **Rs. 3,74,016/- (Rs. Three Lacs Seventy Four Thousand Sixteen only)** rent from April 2018 to March 2019 being the grant for running of working women hostel in rented premises.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this grant immediately after closure of the financial year. However, in default the amount would be recovered as per provision of the Scheme.

4. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

5. It may be ensured that the funds earlier released have been effectively utilised and that the data and facts reported by the organisation relating to physical and financial performance are correct. The Institute/organisation shall submit a component-wise Statement of Expenditure and Utilization Certificate as per prescribed format (GFR-19-A), certifying the actual utilization of grants for the purpose for which it was sanctioned. The organisation should have the capacity to actually spend the balance from the previous years and the releases during the current year.

6. The first instalment was released to the organization of Rs. 4,12,008/- vide Ministry's sanction dated 27.09.2017.

7. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount of Rs. 3,74,016/- (Rupees Three Lacs Seventy Four Thousand Sixteen only) for disbursement to the grantee through electronic transfer. This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 350/AS&FA/2019 dated 18.02.2019. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.

11. The organization will submit Utilization Certificate of the Grant-in-aid by 12.09.2019.
