Subject: **Scheme of Assistance to State Govt. of Assam for Eastern Peoples' Community Participation, Assam for running hostel in Rented Premises at Azad Nagar, Baladmari Municipal Area, Goalpara for Working Women with Day Care Centre for Children - Release of grant-in-aid.**

Madam/Sir,

I am directed to say that the Government of India has approved the proposal of **Eastern Peoples' Community Participation, Assam** for running of Working Women Hostel in the rented building at **Azad Nagar, Baladmari Municipal Area, Goalpara** for 50 working women at monthly rent of **Rs. 25,000/- (Rs. Twenty One Thousand only)** for running of hostel building for working women subject to the condition that in case the actual expenditure on this project is less than the approved rent, the difference between the approved rent and the actual expenditure will have to be refunded by the organization to the Ministry. The approval is as follows:

2. I am, accordingly, to convey the sanction of the President to the payment to State Government of Assam of a sum of **Rs. 4,83,750/- (Rupees Four Lakh Eighty Three Thousand Seven Hundred and Fifty only)** for the period of 09 months from July, 2017 to March, 2018 which is consisting of **Rs. 1,46,250/- (Central share of Rent @65% of Rs. 2,25,000/- (Rs. 25,000/- x 9) and Rs 3,37,500/- as (Central Share @90% of total furniture amount of Rs. 3,75,000/- = Rs. 7,500 per head x 50- as one-time non-recurring grant for purchase of furniture @ Rs. 7500 per head)** being the grant for running of working women hostel in rented premises. Secretary, Social Welfare Department, Government of Manipur is requested to further release the fund to Eastern Peoples' Community Participation, Assam.

3. The Working Women Hostel is a sub-scheme of the Centrally Sponsored Umbrella Scheme "Mission for Protection & Empowerment for Women". In the above release, the Central Government, State Government and Implementing Agency contribution has been calculated as 65:10:25 ratio and sanction of funds is subject to the following conditions;

i. The amount of the grant will have to be utilised for all components under the scheme as per the schematic norms.

ii The implementing agency shall also be required to contribute their share for implementation of the Working Women Hostel Scheme

4. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this grant immediately after closure of the financial year. However, in default the amount would be recovered as per provision of the Scheme.

5. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

6. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will revert to the Central Government.

7. The expenditure involved is debitable to Major Head "3601"-Grant-in-aid to State Governments, 06-Centrally Sponsored Schemes (Sub Major Head), 101 -Central Assistance/Share (Minor Head), 48-Mission For Protection and Empowerment 05-Working Women Hostel (Detailed Head), 31-GIA General (Object Head) under Demand No. 100, Ministry of Women and Child Development during 2020-21.

8. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

9. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principals of the Scheme approved by the Competent Authority.

10. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the


