Subject : **Scheme of Assistance to Sajei Ganakalyan Unnayan Samity, Assam for running Hostels in Rented Premises at Plot No. 10, Baniachuburi Road, Baihata Chariali, Bejera, Kamrup, Assam for Working Women with Day Care Centre for Children - Release of grant-in-aid.**

Sir,

I am directed to say that the Government of India has approved the proposal of **Sajei Ganakalyan Unnayan Samity, Assam** for running of Working Women Hostel in the rented building at Plot No. 10, Baniachuburi Road, Baihata Chariali, Bejera, Kamrup, Assam for 20 working women. Monthly rent of **Rs. 19,500/-** (Rs. Nineteen Thousand Five Hundred only) has been approved for hiring of hostel building for working women subject to the condition that in case the actual expenditure on this project is less than the approved rent, the difference between the approved rent and the actual expenditure will have to be refunded by the organization to the Ministry. The approval is as follows:

- i. Location : Plot No. 10, Baniachuburi Road, Baihata Chariali,
Bejera, Kamrup, Assam
- ii. Area : 184.75 Sq. mt.
- iii. Accommodation: 20 working women and 10 Children
- iv. Rent approved : Rs. 19,500/- per month
- v. Duration : 2 Years

2. I am, accordingly, to convey the sanction of the President to the payment to the Sajei Ganakalyan Unnayan Samity, Assam of a sum of **Rs. 2,92,500/-** (Rs. Two lakh Ninety Two Thousand and Five Hundred only) (Partial 01st instalment of Rs. 58,500/- as rent for April to June, 2018 and 02nd year instalment of Rs. 2,34,000/- as rent for July, 2018 to June, 2019 as being the grant for running of working women hostel in rented premises.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this grant immediately after closure of the financial year. However, in default the amount would be recovered as per provision of the Scheme.

4. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of **CAG (DPC) Act, 1971** and internal audit by the Principal Account Office of the Ministry, whenever the grantee is called upon to do so, as laid down under **Rule 236 (1)** of General Financial Rules. The grant-in-aid extended hereby is subject to the terms and conditions laid down in the grant-in-aid rules.

5. It may be ensured that the funds earlier released have been effectively utilised and that the data and facts reported by the organisation relating to physical and financial performance are correct. The Institute/organisation shall submit a component-wise Statement of Expenditure and Utilization Certificate as per prescribed format (**GFR-19-A**), certifying the actual utilization of grants for the purpose for which it was sanctioned. The organisation should have the capacity to actually spend the balance from the previous years and the releases during the current year.

6. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so. The first instalment was released to the organisation of Rs. 3,25,500/- vide this Ministry's Sanction Order dated 12.03.2018.

7. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount for disbursement to the grantee through electronic transfer. The bank details of SajeiGanakalyanUnnayanSamity, Assam is as under:-
