Subject : Scheme of Assistance to Voluntary Organisation for the Hostels in Rented Premises for Working Women with Day Care Centre for Children - Grants-in-aid to Tirumala Shikshan Prasarak Mandal, Aurangabad for **running of working women hostel in rented building** at 8 Nutan Colony, Near Kranti Chowk, Aurangabad, Maharashtra - Release of grant-in-aid.

Sir,

I am directed to say that the Government of India has approved the proposal of **Tirumala Shikshan Prasarak Mandal, Aurangabad** for running of Working Women Hostel in the rented building at **8 Nutan Colony, Near Kranti Chowk, Aurangabad, Maharashtra** for 50 working women. Monthly rent of **Rs. 49,220/-** (Rs. Forty Nine Thousand Two Hundred Twenty only) has been approved for hiring of hostel building for working women subject to the condition that in case the actual expenditure on this project is less than the approved rent, the difference between the approved rent and the actual expenditure will have to be refunded by the organization to the Ministry. 2. I am, accordingly, to convey the sanction of the President to the payment to the Tirumala Shikshan Prasarak Mandal, Aurangabad of a sum of Rs. 5,71,880/- (Rs. Five Lacs Seventy One Thousand Eight Hundred Eighty only) (Rs. 1,96,880/- as rent for December, 2015 to March, 2016 and Rs 3,75,000/- as one time non-recurring grant for purchase of furniture @ Rs. 7500 x 50) being the grant for running of working women hostel in rented premises.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this grant immediately after closure of the financial year. However, in default the amount would be recovered as per provision of the Scheme.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.


