In continuation of this Ministry's earlier sanction letter of even number dated 8.07.2011 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of Rs. 10,63,133/- (Rupees Ten Lakh Sixty Three Thousand One Hundred Thirty Three only) being the **fourth & final instalment** of grant out of a non-recurring grant of Rs. 1,41,75,095/- (Rupees One Crore Forty One Lakh Seventy Five Thousand Ninety Five only) as Central Government's share for construction of a Working Women's Hostel for 200 working women at Gat No 601, Vadgaon Gupta, Tal. Nagar, Distt. Ahmednagar, Maharashtra by **Padmashri Dr. Vithalrao Vikhe Patil Foundation, Vilad Ghat, P.O. MIDC, Ahmednagar, Maharashtra.**

2. The grant shall be subject to further terms and conditions as laid down in the scheme. This fourth & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount.** However, in default the amount would be recovered as arrears of land revenue.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

4. The Drawing & Disbursing Officer of the Ministry of Women & Child Development is authorized to draw the amount for disbursement to the grantee through electronic transfer. 
