I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 75,00,000/- (Rupees Seventy Five Lakh only) as Central Government's share for construction of a Working Women's Hostel for 100 Working Women with day Care Centre for 25 pre-School Child+ren at Wangbal, Thoubal District, Manipur. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 1,00,00,000/- (Rupees One Crore only as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

- I am, accordingly, to convey the sanction of the President to the payment to the Rural Development Women Organisation of a sum of Rs. 37,50,000/- (Rupees Thirty Seven Lakh Fifty Thousand only) being the first instalment of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first instalment.
- 3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
