Subject : Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Nagaland Handloom and Handicraft Development Corporation Ltd., Dimapur, Nagaland** at Old Town, Zunhebotta Distt. Nagaland - Release of Second instalment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 3,35,52,000/- (Rupees Three Crore Thirty Five Lakh Fifty Two Thousand only) as Central Government's share for construction of a Working Women's Hostel for **100 Working Women** with day Care Centre for **30 pre-School Children** at Old Town, Zunhebotta Distt. Nagaland. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 4,47,36,000/- (Rupees Four Crore Fourty Seven Lakh Thirty Six Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Nagaland Handloom and Handicraft Development Corporation Ltd., Dimapur, Nagaland** of a sum of Rs. 1,34,20,800/- (Rupees One Crore Thirty Four Lakh Twenty Thousand Eight Hundred only) **being the second instalment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this installment along with agency's share immediately after the grant is expended. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 588/JS&FA/2015 dated 19.06.2015. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.

8. Entry has been made in the GIA Register at Sl. No. 1.

9. The organization will complete construction of the Hostel and submit all requisite documents including audited accounts, utilization certificate and completion certificate by 1-03-2016.
